### **Local Subscriptions**

Your 2022/23 local York Group subscription will be due for renewal at the AGM on 15<sup>th</sup> March, 2022.

After a careful review, York IAM Group committee has made the difficult decision to increase our membership annual subscription level from March 2022. The current annual subscription of £6 has not changed in 40 years! If this had increased in line with inflation then our subscription would now be £22.20. The national average local subscription is £11.85. We have also forecasted all our local costs for 2022, and although we currently enjoy free banking, we are concerned that this may change within 2022/3 – so that also had to be considered. We have therefore set our 2022/23 subscription at £12 which will be due for payment in March, following our AGM. The most economical way for us to collect subs is through direct and secure payments from your bank (BACS) – but cheques are also still acceptable.

Our mission is to promote ROAD SAFETY at every opportunity, ideally involving both our current and new members. Your continued IAM & York Group support will mean that we can continue to enhance your heightened awareness of safe driving practice.

In summary, our costs cover member events, venue provision and Observer training. We will expand on all our plans at the AGM on 15<sup>th</sup> March. It would be appreciated if your subscription could be paid by 31<sup>st</sup> March, 2022. Thank you.

# **Changes to the Highway Code**

**Did you know** that changes to The Highway Code came into effect from 29<sup>th</sup> January, 2022.

There are changes in 8 important areas:

- 1. introducing a new hierarchy of road users
- 2. crossing the road at junctions
- 3. walking, cycling or riding in shared spaces
- 4. positioning in the road when cycling
- 5. overtaking when driving or cycling
- 6. cycling at junctions
- 7. people cycling, riding horses and driving horse-drawn vehicles on roundabouts
- 8. parking, charging and leaving vehicles

The UK's leading road safety charity, IAM RoadSmart, has warned that a lack of communication from the government regarding the sweeping changes to the Highway Code means that many motorists will be running the risk of inadvertently breaking the rules of the road.

Indeed, four new rules and 49 changes to the Code include the requirement for drivers to give way to pedestrians at a junction, as well as a new risk-based 'Hierarchy of Road Users', which places more responsibility on the drivers of larger vehicles to look after more vulnerable road users such as cyclists and pedestrians.

And while IAM RoadSmart has welcomed some of the changes, the charity has cautioned that the new rules will be of very little benefit if the public aren't made aware of them.

Neil Greig, Director of Policy and Research at IAM RoadSmart, commented: "There is very little evidence from trials or pilot schemes that the new hierarchy or rules will help people feel safer undertaking active forms of travel, which has huge benefits in terms of personal health, local communities and the environment.

The vast majority of people won't have read the Highway Code for many years, meaning it is absolutely essential that changes are communicated in a simple, memorable and timely fashion. Unfortunately, this has not been the case so far, meaning there is now huge potential for more conflict on the roads rather than less.

"IAM RoadSmart will continue to inform its members and the wider public about such changes, but the government must also do more to effectively raise awareness of the changes coming in."
