COVID-19 update from IAM RoadSmart

Further to our notification earlier this week, following the Government announcement of further restrictions in England and the ongoing restrictions in Northern Ireland, Scotland and Wales, we have taken the difficult decision to temporarily suspend all our car and motorcycle on-road training, testing, observing and any in-person group activities across the UK from Thursday 5 November 2020.

This decision has not been made lightly. However, the IAM RoadSmart Trustees and Senior Management Team believe these steps are in the best long-term interests of our charity and our mission to reduce the number of people who are killed and injured on the UK's roads.

It also ensures everyone at IAM RoadSmart – our colleagues, examiners, trainers, groups, members and customers – plays their part in minimising the spread of the virus. We believe this is the responsible thing to do.



From the M62 East leave at junction 30 and take the A642 towards Wakefield.



First of all, I would like to thank all of you taking part in this virtual meeting for your interest in the Group and for helping us to meet the requirements for the quorum. You are very welcome, and I am only sorry we are having to meet in such strange circumstances.

Until 23rd March, MYAM was having a successful 2019/20 year, and I will leave it to Rosie Bricis (our Treasurer), Paul Macro (our Secretary), and David Rushfirth (our Chief Observer) to give you all the facts and figures. I will just say that last year we attended at least ten car rallies and other events to publicise MYAM, and although it is almost impossible to quantify the number of

new Members we get as a result of such events, attendance at them is vital to "spread the word".

In addition, I continue to sit on the Wakefield Safer Roads Committee, the WY Police Scrutiny Committee, and the WY Police Independent Advisory Group, so that MYAM is well known and recognised in and around the area. The meetings are, of course, currently being held by video conferencing, but we are still receiving and exchanging information.

As a result, I can say that, even though the normal routine of the Group has been severely disrupted by the current situation - no Skill Check drives, no monthly social speaker meetings, no classic car events, etc. - there is still plenty going on behind the scenes. Our monthly newsletter still goes out on time (thanks to Keith Wevill and David Rockliff), monthly committee meetings are still held on line (thanks to David Rushfirth), all aspects of governance and Gift Aid are still maintained (thanks to Paul Macro), accounts are kept up to date (thanks to Rosie Bricis), and contact is still maintained with our Members, Associates, Observers, and with Head Office.

I am therefore saying a very big thank you to all the MYAM Committee, who make all of this possible; and a big thank you to you, the Members, for your loyalty and support.

Treasurers Report

A brief summary of our accounts for the year April 2019 to March 2020.

First of all, a very big thank you to David Stringer, who checks our accounts to ensure that they are compliant.

As with previous years, MYAM has spent a bit more money than it received: our income was £3,968 and our spend was £4,093. However, we do have some money in reserve for when we need to replace the caravan and this helps tide us over.

The income we received from subscriptions increased from the previous year. But we had fewer payments from IAM head office for new Associates: the last payment was in February as, shortly after, we had the Covid-19 lockdown.

The largest amounts of money were spent on:

The monthly group meetings and the committee meetings, which was just under £1K, and included hire of the room for all of our meetings and also two buffets: one for last year's AGM and for one for last year's Xmas quiz night.

Costs for the caravan (a major asset!) were just under £900 and this included parking fees, service and mileage to the monthly skill-check meetings and events like the various car rallies and shows.

Stationery and printing were also quite big expenses, just over £700, which is why we prefer to send out our monthly newsletter by email, rather than printing and sending in the post.

We spent just over £300 on books for Observers and Associates, such as Highway Codes, and Observer road books; and also on a microphone system for our monthly meetings.

And another £300 on training, which included refreshments for the Sunday morning training sessions and room hire for Observer training.

Thank you to everyone who is paying their subscriptions via GoCardless, this is a great help to the Group. However, please do check that, if you do, that you've cancelled any previous standing orders — we have a few refunds to sort out for people who have paid their subscriptions twice.

And, if you can, please do sign up for Gift Aid for your subscription, as any money we can recover is a help to us too.

Membership Secretary's Report

Looking back at the year it has been a little challenging. In particular a new membership database has made the compliance with IAM RS membership rules easier to manage but has cost us in membership numbers, down 25 from 282 to 257.

This was mainly due to the IAM Membership rule requiring membership of the IAM before membership of MYAM can be renewed. The application of this rule also saw the loss of 10 honorary members.

As part of the rule update we have had to remove the Friends and Guests membership categories from the Grroup, which resulted in a further loss of 3 non-paying members. We managed to retain most of those by creating a new "Newsletter Receiver" category. Those members do not however gain benefit from our Observers and training.

Chief Observers Report

The number of Associates remains steady with the same number as last year of 44. We had an intake of 52 Associates over the 12 months against a total of 58 in the previous year. We would have been on the same target had it not been for the lockdown impacting the figures for March and April this year.

Associate training remains consistent with the average number of runs to test being 13. During the 12 month period we had 33 test passes with 10 of those being Firsts. We did have 2 test fails although one of those went on to pass on the second attempt. Some Associates decided not to take the test, being happy with the training they received. A big thank you to all the Observers for the efforts in training these Associates.

Associate recruitment and public awareness events were well received with 14 events attended, most as full day sessions at various car shows where the Group caravan was put to very good use. We had to replace our aging generator at the beginning of the year with a new one kindly donated to us by Isinglass Consulting. Thank you to Paul Macro for arranging this.

The Skill Check sessions are still as popular as ever with 72 individual runs being provided from Leeds and 107 from Castleford. Our thanks go to both McDonalds in Leeds and Sigma in Castleford for the free use of their car parks for these sessions.

Lockdown has forced us to cease all Associate training. All Advanced driving tests have also ceased. When we can restart is currently unknown.

The number of Observers remains relatively stable at 29, increasing by one this year and currently includes 3 trainee Observers. We do still need Observers so that we can continue to provide training and reduce the waiting time for Associates. We need to improve our coverage to Bradford, Mirfield and Harrogate. If anyone is interested for any area, please get in touch.

Observer training went well with a day's session in September concentrating on Roundabouts, Cornering and parallel parking an expertly delivered by David Stringer. We also held some Observer Training at the Castleford Skill check session. We will be arranging further training days covering different subjects.

That's it from me for now and what the next 12 months will bring is anybody's guess.

Are You Opinionated?

I am pretty sure that MYAM members enjoy a day at the seaside as much as anyone, and there will be few who have not visited the Yorkshire coast. Indeed, I would guess it was as likely a destination as any when we began to regain some freedom in this most peculiar of summers.

It has a drawback. It's known as the A64. One of the prime routes to the coast. It's a road I am very familiar with, and have been for many years, as my wife's family originate from Malton. Once astride the A64, the town now enjoys a bypass, much to the relief of the residents. For those of you old enough to remember the days when the A64 went through the very centre of Malton, you will probably remember the horrendous traffic queues, particularly on Bank Holidays. And that in the days when there was far less traffic on the roads. However I recall my father in law, who was in the motor trade, rubbing his hands together in anticipation at the breakdowns, as many aging cars struggled to reach Scarborough in such conditions. It's an ill wind, as they say.

These days the by-pass has the problem, caused by being book ended by single carriageway stretches of road. Late afternoon at the west end of the bypass can be particularly entertaining as the ambling holiday traffic does battle with the rushing commuter traffic as everyone heads home.

The west end of the Malton bypass dual carriageway is approached round a very long, sweeping left hand curve, which is followed by a straight length well signed to move traffic into a single lane where the road out of Malton slips in from the left at the start of the single carriageway to Crambeck. When the traffic gets heavy, a queue tends to form. In the left hand lane. It cannot normally be seen until you are relatively close, but soon enough to brake safely from the 70 mph limit. In the event you are with the rushing commuter traffic overtaking the ambling holiday traffic, the notion of coming down from, say, 70 mph to 50 mph or so, changing lanes at the same time and then coming to an orderly stop at the end of a single queue is, to say the least, imaginative. It is simply dangerous, so a certain amount of traffic inevitably finishes up in the outer lane rolling past the long queue on the left.

Now being advanced drivers we all follow the rules and guidance of the Highway Code. We do, don't we? Or do we just think we do? So why then do so many people get quite so worked up when a situation such as I have just described arises? If you are in the

outer lane you get glowered at, drivers intentionally close up so there is no room for you to merge into the queue, others pull out to block your lane and stop your progress. Now here is where you have to get opinionated.

In such circumstances, where two lanes need to merge into one, should we stick to good old polite British reserve and form one orderly queue immediately, leaving a whole lane empty, or fill both lanes equally and merge in turn at the very front? After all, we pay enough to use the road, so does it not follow that we should use all of it if it is safe to do so? As Yorkshiremen (pure bred or adopted) we appreciate value for money. Think of Arkwright in Open All Hours. "'Ow much??' "

Before you reach for your Highway Code, I'll tell you the relevant paragraph is best described as a 'grey area', although there is good reason for what it says. So whichever view you hold may be tenable. Try to work out which approach is safer, both from the view of those who edit the guidance in the Highway Code, and our view as advanced drivers. Now read Rule 134.

It is the concept of braking fairly heavily and changing lanes at some speed that causes the advice in this case to read as it does. If the traffic forms two queues and vehicles politely merge in turn it is done at much lower speed, possibly at mere walking pace from a standstill. The result is far safer and causes fewer accidents. Clearly there can be different road circumstances where the end of the queue is more visible but the west end of Malton bypass really does make the point that two queues and zip merging is the safer method. A few miles further along towards York, the end of the next length of dual carriageway reinforces the point. Here the road bends left rising to a crest, and a single queue on the following long straight towards the head can be very, very close to that crest. Braking from 70 mph here can be challenging and it can be safer to go out into the empty outer lane. Surely two queues half the length would obviously be wiser. Both would be visible with adequate braking distance.

I remain neutral. You could say I duck out. Opinions in writing, please, to the editor! Mallard.
