#### **Directions to the Birkenshaw Liberal Club**

10 Croft Street, Birkenshaw, Bradford, BD11 2HT









From the M62 West leave at Junction 26 and take the A58 towards Leeds. At the second roundabout turn left into Bradford Road (A651) after about 700yds by the George pub, turn right into Town Street. Croft Street is approximately 60yds from the junction (top photo left) but to avoid the potholes carry on up Town Street and turn right into Old Lane. After approximately 100yds turn right into Croft Street (middle picture left between the car and the house next to it).

From Bradford follow the A650. Turn right onto the A651 at the traffic lights just before Tong Academy. Then just after the George pub turn left into Town Street and follow the previous directions.

From the M62 junction 27, take the A650. Turn left onto the A58. After approximately ½ mile turn right into Old Lane. After approximately 550yds turn left into Croft Street (bottom picture left).

There is a large car park and the entrance is down the right hand side of the club as shown in the top picture.

Our meetings are held in the function room.

# November Meeting Tyre Safe

How often do you check your tyres? Every week, every month, just before the MOT or never? According to Stuart Lovatt, chair of Tyre Safe, 73% of motorists do not check their tyres and 29% of motorists wait for the MOT and 35% never think to check their tyres.

The aim of the Tyre Safe campaigns is to raise awareness of the importance of correct maintenance and the dangers of defective and illegal tyres. Driving with illegal tyres can lead to a fine of £2500 and 3 penalty points per tyre.

Some of the statistics given were frightening especially when you consider that your tyres are the only point of contact your car has with the road. Most of the vehicles that had been involved in an accident and had been recovered to a police compound were found to have defective tyres which was probably a factor in the accident.

In 2023 the AA recorded 620 thousand tyre related faults and 28% of tyre replacements were due to potholes and poor road surfaces

A new tyre has typically 8mm of tread which has to shift up to 30 litres of water per second at 40mph but as the tread wears down the ability to shift the water diminishes. The legal minimum tread depth is 1.6mm but ideally tyres should be replaced before this point is reached hence the need for regular checks. These should include the checking pressures, details of which should be in the vehicle handbook or on the fuel filler cover. It is also important to check the tread depth across the width of the tyre. If the tread depth varies across the width it could indicate that the tracking is out and needs adjusting.

Many motorists when looking for replacement tyres will choose some of the budget brands but although these may be cheaper they are not necessarily as good as the premium brands. Stuart showed a video comparing the stopping distance between budget and premium tyres in wet conditions. There was a 78ft difference in the stopping distances. Some motorists change their tyres to winter tyres for the colder months replacing them when the weather improves in the spring. As an alternative to winter tyres it is also worth considering All Season tyres. These have a different tread pattern and can perform better in winter conditions than "normal" tyres. I can vouch for that as I've had All Season tyres on my last two cars and never had any major issues in bad weather.

The Chief Observer needs to be an IAM National Observer, but we are very willing to provide relevant training / refresher sessions for anyone who may be interested.

In addition, we are willing to discuss further splitting the CO role amongst several people if this is required.

#### **Cars With Potential Future Problems To Avoid Buying**

A mechanic has warned motorists looking to buy a reliable used car to avoid models that come with a certain set of features, warning they may be problematic in the future. David Long is better known to fans as Car Wizard thanks to his YouTube videos in which he repairs classic and performance models and gives tips to help viewers cut down their motoring bills.

EVs, if you find one that doesn't have a 'battery charge' level but a 'battery health' level. These tell you how much time you have left before a battery needs to be replaced.

"There are plenty of electric vehicles on the used car market where you should be looking at the battery health meter. If it's below half, you probably should not buy that vehicle, it could cost you tons to get that battery pack replaced, and that's if you can even find a battery pack." Much like modern smartphones, many of the latest electric cars will give owners an estimation of how much life is left in the battery pack.

Whilst some models have proven that electric vehicles are capable of being used for more than 400,000 miles, examples used in extreme climates or rapid charged unnecessarily can wear out at a faster rate. Checking the health of the battery is crucial to avoid having to buy a replacement, which can be troublesome to fit and, depending on the model, cost more than the vehicle itself to buy.

Later in the video, David also urged drivers to avoid cars where all of the functions are controlled via a central touchscreen, warning that when it fails it will leave owners stranded. He continued: "The next one is going to be a future issue, but it's probably already starting to become one. So many cars are starting to come with an all-inclusive screen, like in the centre of the dashboard. It's your speedometer, tachometer, climate control, the radio, the map, everything that you need to know to drive your car on that screen.

"What happens when that screen fails? It is going to fail. Now you don't know how fast you're going, where you're going, you can't control your air conditioning because it's just a black screen."

Finally, the mechanic suggested that cars in which features are controlled via a smartphone app could have a limited shelf life, with manufacturers or operating systems ending support for them after a few years. He added: "On your phone, you can remote start the car, turn on that feature, turn off that feature, look at the charge level of an EV. We all know that technology moves fast and is ruthless. It does not care if it leaves you behind

with unsupported technology. "We've seen that in all kinds of things today where something works just fine, you move to a new operating system that the company no longer supports, and now you have a brick, it's useless. Imagine having a car that's 15 to 20 years old and you lose all of the features because the app for it is unsupported. I foresee that being such a big problem."

We also had Wakefield Road Safety Officer, Helen Kilner present to us in June, during which she talked about the West Yorkshire Vision Zero initiative, which aims to eliminate all deaths on West Yorkshire roads by 2040. We also had TyreSafe present to us about the importance of looking after our tyres at the November evening. ## Autumn Budget 2024 – IAM RoadSmart reaction



#### **Announcements:**

#### Fuel duty (frozen)

IAM RoadSmart Policy and Public Affairs Manager William Porter said: "We welcome the Chancellor's decision to maintain the fuel duty cut, at least for now. Motorists have endured a torrid few years of high prices at the pumps and this decision will give them a much-needed boost. We separately welcome the commitment to introduce the Fuel Finder scheme by the end of 2025, which should increase pricing transparency at the pumps."

#### Pothole funding (proposed £500m boost)

IAM RoadSmart Director of Policy and Standards Nicholas Lyes said: "Any additional funding to fix our crumbling and potentially unsafe roads is welcome, but with one-off repair bill of over £16bn, the amount promised by the Chancellor is a drop in the ocean of what is required. Given the risks that potholes pose to both drivers' wallets and riders' safety, we need a longer-term approach to funding so councils can prioritise resurfacing work where it is most needed."

#### Vehicle Excise Duty (increased on first year)

IAM RoadSmart Director of Policy and Standards Nicholas Lyes said: "Increasing vehicle excise duty on all but zero emission vehicles in the first year will hit those buying new conventional vehicles in the pocket. A better solution to incentivise the take-up of electric vehicles would have been to cut VAT on the sale of new electric vehicles with list price of £40,000 and under."

#### What was not announced:

#### **Insurance Premium Tax**

IAM RoadSmart Policy and Public Affairs Manager William Porter said: "At a time when insurance premiums are at near record highs, not using the Budget as an opportunity to reduce insurance premium tax for young drivers who undertake additional

training is a missed opportunity to both reduce their premium costs and improve road safety. Younger drivers have seen their quotes skyrocket into the thousands and sadly risks many in this age group being priced out."


#### Older drivers (no support for mature driver assessment)

IAM RoadSmart Director of Policy and Standards Nicholas Lyes said: "We're disappointed the Chancellor has missed this opportunity to provide support and peace of mind for older drivers in her Budget. Our plan for optional, free driving assessments for over-70s would have the benefit of boosting the confidence of older drivers and a potentially positive impact on reducing collisions on our roads."

#### **VAT exemptions (motorcycle PPE)**

IAM RoadSmart Director of Policy and Standards Nicholas Lyes said: "Our campaign for motorcycle air vests and other protective clothing to be exempt from VAT will continue. Per billion miles travelled, motorcyclists are by far the most vulnerable road user and encouraging them to invest in life-saving riding gear that reduces fatalities and serious injury should be a priority for Ministers."

The book was published in 2013 but is still available online from Pen and Sword books in Barnsley.


Following on from the recent meeting about tyre safety, it contains the following note:
