

From the M62 West leave at Junction 28 and take the A650 towards Wakefield. At the next set of traffic lights turn left onto the A654 toward Rothwell. Follow the A654, turning left in Thorpe on the Hill. Cross the A61 and continue into Carlton. Turn right into Stainton Lane then turn right into Main Street. The Social Club is on the right immediately after the Unicorn pub.

From the M62 East leave at junction 30 and take the A642 towards

Wakefield. Take the next right, B6135, towards Lofthouse. Follow the B6135 under the M62 onto Ouzlewell Green towards Carlton and Rothwell. Follow the road past Carlton Primary School and the Social Club is on the left just before the Unicorn pub.

There is a car park with overspill parking available on the grass area opposite the club.

Extraordinary General Meeting

As you will see from this newsletter, the MYAM Committee has called an Extraordinary General Meeting (EGM), which will take place at 8:30pm, immediately following our AGM on Monday 4th October 2021. In order to accommodate this additional short meeting, please note that the time of the AGM has been brought forward to 7:30pm, and the reason for the EGM is as follows:

A few weeks ago, a member of the Skipton & Craven Group Committee contacted me to say that, for various reasons beyond their control, their Group would unfortunately have to close. As a result, the Committee had asked him to contact me and ask whether the MYAM Group would be willing to consider their Members joining us.

As this is an old-established Group with a small, but loyal, membership, I am reluctant to see its disappearance, and so I am writing this article to you, the MYAM Group Members.

Obviously, in such a situation, both the Skipton & Craven and the MYAM Groups have to follow correct courses of action as laid down by both the Charities Commission and the IAM RoadSmart regulations. These procedures include the calling of individual EGM's by both Groups to ensure that all the Members are in full agreement with the winding up of Skipton & Craven and their subsequent joining with MYAM.

The Skipton & Craven Group EGM will be held on the 29th September 2021, and, providing that two thirds of the Members attending the meeting are in favour of winding up the Group and the Membership's joining with MYAM, then the MYAM Group must hold our own EGM to agree to accept the amalgamation. As our own AGM has already been called for the 4th October, then it seems only sensible to hold the EGM immediately following on the same evening. There will be only one item on the agenda of the EGM, i.e. whether the Members of MYAM are in agreement with the Members of the Skipton & Craven Group's joining the MYAM Group.

In order to give you some facts prior to the EGM, this is the information I have been given so far:

- 1. The current membership of the Skipton & Craven Group is approximately 40.
- 2. At least one Member of the Skipton Committee is willing to join the MYAM Committee.

- 3. The Skipton Group's Chief Observer (National Observer, Local Observer Assessor, and Observer trainer) is willing to join MYAM and continue in those roles.
- 4. In addition, 2 qualified Observers and 2 trainee Observers are willing to join the MYAM team.
- 5. The Skipton & Craven Group funds will be available for transfer to MYAM. This will help with training, purchase of equipment and recruitment.

It must be borne in mind that the Skipton & Craven Group territory is large, but, with the support of the membership of both Groups, it is better that we engineer a joining of the Groups rather than allow a Group to be lost. However, in order to carry this out, we do need the help and support of all the Members of both Groups. We urgently need more Observers throughout both areas (particularly in the North and West of the current MYAM area), and I am now asking whether you would be able to give the time to train as an Observer and take on at least one Associate. At the moment, both Groups have a waiting list of Associates, and so any additional Observers will be very welcome to reduce the waiting time – and you would certainly play a large part in helping an organisation which I know you hold in high esteem.

Please think very carefully whether you could give a little time to your Group. If you can give some time, please contact the MYAM Chief Observer, Chris Marrison, on <u>myam.chiefobserver@outlook.com</u> or me direct on <u>myam.chairman@outlook.com</u>

I do hope you will vote in favour of the Skipton & Craven Group's Members joining MYAM, but, in the meantime, should you have any questions, please do not hesitate to contact me.

IAM News Releases and Tips IAM RoadSmart welcomes Direct Vision Standard to reduce lorry blind spots



IAM RoadSmart, the UK's largest independent road safety charity, has welcomed the enforcement of rules to raise driver visibility standards in lorries to reduce incidents caused by blind spots.

It follows moves that now require all lorries over 12 tonnes to have a Direct Vision Standard (DVS) safety permit which is enforceable across inner and outer London in a bid to provide more protection for vulnerable road users, such as pedestrians and cyclists.

More than 90,000 heavy goods vehicles have already been awarded permits.

The legislation is part of London Mayor Sadiq Khan's 'Vision Zero' initiative aimed at eliminating road deaths and serious injuries on London's streets by 2041.

The legally required safety permit is based on a Vision Star rating which shows how much a driver can see other road users directly from their HGV cab and, subsequently, if any safety equipment needs to be fitted to the vehicle.

Neil Greig, IAM RoadSmart Director of Policy & Research, said: "Once again Transport for London is leading the way on the use of procurement standards to drive road safety.

"If direct vision standards can be a requirement in London, then IAM RoadSmart can see no reason why they should not be specified in transport contracts across the UK."

Safety technology to bring non-compliant lorries up to the required standard includes blind-spot cameras with in-cab video displays, audible left-turn warning systems and prominent warnings on the rear of the vehicle.

Meanwhile, IAM RoadSmart is urging that direct vision should be a contractual requirement for companies buying in transport services in urban or sensitive areas where they know pedestrians and cyclists may be at risk.

Neil added: "While a few companies understand that good road safety helps them deliver on corporate social responsibility, every company understands financial benefits and these can be substantial for fleets who embrace a safer culture. The new standards are a big step in the right direction, but they could be enhanced even more if TfL was to insist on mandatory training for HGV drivers. Educating cyclists and pedestrians on the risks to them caused by limited vision from large vehicles must also continue."

Observer Training Day

The Group is proposing to hold an Observer Training Day on Saturday 25th September with a 9:30am arrival for a 10:00am start and finishing at 3:30pm. The venue is yet to be confirmed but hopefully no more than a 45 minute journey for any attendee.

The day will be jointly run by MYAM (David Stringer and myself) alongside Steve Ellis, IAM RoadSmart Area Service Delivery Manager, and a number of supporting instructors. The focus will be on the development of Observer Competencies both at Local and National Observer level. The introduction and initial presentations will be delivered at the selected venue followed by on-the-road sessions using both instructor and observer vehicles with a maximum of 2 observers and 1 instructor per vehicle. Observers must therefore be comfortable travelling and driving with a number of passengers. It is planned to provide refreshments and a light buffet lunch.

In order for the planning and preparation of the day, can I please ask for confirmation of your attendance at the event by no later than Monday 6th September. If you have any specific dietary requirement/restriction, please provide details at the time of confirming your attendance.

A number of venues are currently being discussed however, should you be aware of a venue meeting requirements and providing easy access to suitable training routes, please feel free to forward details onto me for consideration.
