NOMINATION FORM

Pease note – You may not stand for the Committee if the law debars you from being a Charity Trustee.

- Only fully paid up members of the IAM and of the Group may nominate Committee Members or be nominated as Committee Members.
- This Nomination Paper must be returned to the Group Secretary at least seven days before the election i.e. by 16/7/20. (Rule 3.5)
- All Officers and one third of all other Committee Members must retire annually by rotation and may offer themselves for re-election by Group Full Members. (Rule 3.4)
- Nominations may be accepted from the floor of the meeting if a written nomination has not been received and the person nominated from the floor is present and agrees to be so nominated. (Rule 3.5)
- The number of Committee Members including the Officers must not exceed twenty.

This year we had to cancel the AGM that was to have been held in April because of Covid 19. We are required to hold the AGM no later than 18 months after the previous one. Since it is uncertain yet when we may be able to meet in person, the committee have decided that we will have to hold a virtual AGM online via Zoom on July 23rd.

I have been using Zoom daily for work since March and have found it to work well. There has been some concern regarding the security of Zoom meetings and so called "Zoombombing". This is usually where a meeting code has been shared on social media. Our meeting is password protected and not shared on social media. If we keep the code and password within the group there should be no security issues. As host, I also have control over who enters the meeting and can remove participants as well as lock the meeting once it is open so no one else can enter. I hope that reassures you.

These are the details you will need to access the meeting.

The meeting code and password are highlighted in red below. If you are already familiar with Zoom this is all you need. If you haven't used Zoom before, visit the link below and you will be prompted to download the Zoom application software. If using a desktop computer or laptop, you will need a microphone and webcam (webcams usually have built in microphones) in order to be seen and heard. If you don't have either, you can still join by computer and see other attendees but need to dial in by phone in order to be heard. You can use one of the numbers below.

If you have a smartphone or tablet, there is a zoom app for these that is very easy to use.
